

Privacy policy

We at Kyugo are committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your personal information when you use our Kyugo Mobile App ("the App"). Please read this Privacy Policy carefully to understand our practices regarding your personal information and how we will treat it. By using the App, you agree to the terms of this Privacy Policy.

1. Information We Collect

1.1 Personal Information

We may collect personal information that you provide directly to us when you use the App, such as your name, email address, and payment information when subscribing to our services.

1.2 Usage Information

We may collect information about your use of the App, including the types of events and activities you add to your calendar, the frequency and duration of your app usage, and other usage statistics.

The Kyugo App is not intended for use by individuals under the age of 18. We do not knowingly collect personal information from children. If we become aware that we have collected personal information from a child without verification of parental consent, we will take steps to remove that information from our servers.
